Election of Officers

When the item was called, Commissioner Blake made a motion to re-elect Dale Eyeler as Chairman.

Motion to approve Dale Eyeler as Chairperson was made by Commissioner Blake, and seconded by Commissioner Ali. The vote passed 7-0.

Commissioner Ali made the first motion to re-elect Michele Blake as Vice Chairperson, and seconded by Commissioner Doscher. The vote passed 7-0.

Jana Shannon was elected as the Yuba City Planning Commission Representative for Sutter County. The motion to approve was made by Commissioner Adams, and seconded by Commissioner Ali. The vote passed 7-0.

3. Minutes of November 13, 2019

Public Meeting

4. General Plan Amendment GPA 19-03 filed by the City of Yuba City to amend Policy No. 5.2-I-12 of the Yuba City General Plan Transportation Element to add the segment of Bridge Street between North Palora Avenue and Second Street to the list of streets where exceptions to the minimum Level of Service (LOS) D are allowed. The policy amendment would provide for a LOS F on this street segment, where LOS A represents uncongested traffic operations and LOS F represents potential stop-and-go traffic operations. The City has completed a Draft Supplement to the 2004 General Plan Environmental Impact Report (SEIR) for this project, Environmental Assessment 19-08, consistent with the California Environmental Quality Act (CEQA) Guidelines Section 15163. The SEIR focuses on potential impacts related to traffic and circulation, and included completion of a traffic study.

Recommendation

Staff recommends that the Planning Commission take the following actions:

- A. Approve the Resolution, recommending to the City Council adoption of the Supplemental Environmental Impact Report (EA19-08); and
- B. Approve the Resolution, recommending to the City Council approval of GPA 19-03, allowing for recognition of Level of Service F along the portion of Bridge Street located

between North Palora Avenue and Second Street.

Item called. Staff made a presentation, and the public was given an opportunity to speak on the item. After the public hearing was closed, and after deliberation, a motion to approve recommendation A and B was made by Commissioner Ali, and seconded by Commissioner Schaffer. The vote passed 7-0.
