# 3. Minutes of March 25, 2020

### **Public Meeting**

4. Consideration of a requested 18-month extension of time to file a Final Map for Tentative Parcel Map (TM 17-04). Tentative Parcel Map 17-04, located on the east side of Sanborn road, approximately midway between Lincoln Road and Bogue Road was approved with an effective date of May 23, 2018. The subdivision would allow a 2.35-acre parcel into three single-family residential lots and one remainder lot. Two residential lots being approximately 6,050 square feet in size, the third lot being 5,823 square feet, with the remainder parcel of 1.93 acres; (APN 56-030-054).

**Recommendation:** Approve an 18-month extension of time for Tentative Parcel Map TM 17-04 pursuant to City Municipal Code Section 8-2.610, resulting in a new expiration date of November 23, 2021.

Item called. Staff made a presentation, and the public was given an opportunity to speak on the item. After the public hearing was closed, and after deliberation, a motion to approve the recommendation was made by Commissioner Blake, and seconded by Commissioner Ali. The vote passed 7-0.

5. Planning Commission's annual consideration and review for consistency with the General Plan of the draft Capital Improvement Program (CIP) for the fiscal years 2020/2021 through 2024/2025.

**Recommendation:** Planning Commission find that the Capital Improvement Program is consistent with the Yuba City General Plan and forward their finding to the City Council.

Item called. Staff made a presentation, and the public was given an opportunity to speak on the item. After the public hearing was closed, and after deliberation, a motion to approve the recommendation was made by Commissioner Shannon, and seconded by Commissioner Doscher. The vote passed 7-0.

### **Public Hearings**

6. Public hearing for the adoption of a Mitigated Negative Declaration (MND) and consideration of a Development Plan (DP 19-04) to allow the construction of a 64,000 square foot agricultural walnut and prune processing and cold storage facility. The MND has been prepared in conformance with CEQA Guidelines, Section 15070. The 15.95-acre project is located at 2179 Franklin Road; (APN 63-040-012).

**Recommendation:** Conduct a public hearing and take the following two actions to adopt the Mitigated Negative Declaration pursuant to the California Environmental Quality Act, Section 15070; and approve Development Plan 19-04 to allow the construction of a 64,000 square foot agricultural walnut and prune processing and cold storage facility located at 2179 Franklin Road, Yuba City, CA, subject to making the necessary findings as presented, and the Conditions of Approval.

Item called. Benjamin Moody, Development Services Director, stated the applicant has requested to move the hearing to a date certain on the June 24, 2020, Planning Commission Meeting.
