2. Appearance of Interested Citizens

Members of the public may address the Planning Commission on items of interest that are within the City's jurisdiction. Individuals addressing general comments are encouraged to limit their statements to three minutes.

Commissioner Dale arrived at 6:02 PM following the Roll Call

3. Agenda Modifications

Chairperson Sillman requested approval of the agenda.

4. Minutes from May 31, 2023

Chairperson Sillman requested approval of the minutes.

Business Items

5. Consideration of a General Plan Amendment (GPA) 23-02 and Rezone (RZ) 23-02, Bains - Bridge Street, located at the North side of Bridge Street and west of Walton Avenue.

Item was called and Doug Libby, Deputy Development Services Director, gave a presentation.

Commissioner Comment:

Vice Chair Brookman asked about existing site grading and the installation of infrastructure.

Deputy Director of Development Services, Doug Libby, answered that there is no proposed project at this time but noted the subdivision that is under construction.

Commissioner Nore asked for clarification regarding the allowed density, and the density that staff believes will be built-out. He asked if the density that will likely be built would be in the range of 4-9 units. or 9-24 units.

Deputy Director of Development Services, Doug Libby, answered that 9-24 units an estimate of what can be built.

Vice Chair Brookman asked if a proposed development plan on the site would come back to planning commission to be voted on.

Deputy Director of Development Services, Doug Libby, explained the Municipal Code requirements that would allow a future project to be approved at the staff-level and what may require Planning Commission action.

Deputy Director of Development Services, Doug Libby, requested the Planning Commission modify Section 4. c. of the proposed resolution to reflect an anticipated density of 9-24 units and replacing the reference of 4-9 residential units as listed.

Vote: The motion passed 7-0 with all commissioners in attendance.

The motion was passed with the requested modification of the staff report.

6. Consideration of Use Permit (UP) 22-04: Harter Marketplace (ARCO), UP 22-05: Harter Marketplace (Raising Canes), and UP 22-06: Harter Marketplace (Dutch Bros Coffee), located at the northwest intersection of State Route 20 and Harter Parkway.

Item was called and Doug Libby, Deputy Development Services Director, gave a presentation.

Commissioner Comment:

Commissioner Campbell asked if each resolution can be independently voted on, given that they're bundled together.

Deputy Director of Development Services, Doug Libby, confirmed that each resolution can be independently voted on.

Public Comment:

Leslie Burnside, Barghausen Consulting Engineers, Inc, Introduced the project representative team members that were in attendance, and expressed excitement about the project and joining the community. Leslie also indicated that the team was in full agreement with the conditions of approval.

Robert Montgomery, Director of Property Development with Raising Canes, talked about the quality and values of Raising Cane's. He also expressed that Raising Cane's will be very supportive of the community.

Commissioner Campbell asked if Raising Cane's would have indoor dining or if it would be drive-thru only.

Robert Montgomery, Director of Property Development with Raising Canes, responded that yes there will be indoor dining.

Kacey Held, Senior Civil Project Manager with Barghausen Consulting Engineers, Inc, expressed excitement to be a part of the community, and indicated that she is available for any questions.

Chair Sillman expressed that she loved the opportunity that the Dutch Bros brought to the community, providing jobs for young people. She also complimented the marketing and design of Dutch Bros.

7. Consideration of a determination of General Plan Consistency regarding Sutter County land acquisition.

Item was called and Doug Libby, Deputy Director of Development Services, gave a presentation.

Commissioner Comment:

Commissioner Gill asked why Shanghai Bend Road was being included, and who would maintain the road.

Deputy Director of Development Services, Doug Libby, indicated the land in question is State-owned and that this acquisition would transfer ownership from the State to Sutter County, with a potential for the city to acquire it in the future. The City maintains the road, whether the land is Sutter County owned, or State owned.

Public Works and Development Services Director, Ben Moody, provided background of the property and explained this item would begin the process of addressing these issues in the area.

Commissioner Gill asked if there are any other State-owned roads or easements.

Public Works and Development Services Director, Ben Moody, confirmed there are in various places throughout the county.

Chairperson Sillman asked if this land acquisition has anything to do with the parkway connecting to other parkways, or is it part of a master plan.

Neal Hay, Sutter County Director of Development Services, answered that potentially in the future it could move forward. He also indicated he is appreciative that the Sutter County Resource Conservation District brought this matter to the City and the County's attention.

Vice Chair Brookman asked who would be responsible for law enforcement services in this area.

Neal Hay, Sutter County Director of Development Services, indicated that an agreement would need to be made between the police department and the sheriff's office.

Public Comment:

No Public Comment.

Commissioner Campbell asked if there is anything that precludes him from voting on this item, with him being a representative of the county. The consensus was no.

Deputy Director of Development Services, Doug Libby, answered yes it recently went out.

Chairperson Sillman asked when the next Planning Commission meeting will be.

Deputy Director of Development Services, Doug Libby, stated staff intends to cancel the August 9th meeting, and we are looking to reconvene on August 23, 2023.

Development Services Director Report

Public Works and Development Services Director Ben Moody addressed the following items:

- The rezone for the West Walton Village Subdivision Map was approved at the last City Council meeting.
- Recent action at City Council entered the city into an agreement that Deputy Director of Development Services, Doug Libby, will be the executive officer for LAFCO.
- The department has received a building permit application for a new Hawaiian restaurant adjacent to Jim Boys Tacos and it is currently being reviewed.

Commissioner Comment:

Commissioner Gill asked if the City has objective design standards.

Director of Public Works and Development Services, Ben Moody, answered no, however there is a push to adopt a set of objective design standards and it is something being worked on. He indicated the department open to suggestions from the Commission.

Public Works and Development Services Director, Ben Moody, noted for the record that Commissioner Dale arrived at 6:02 PM.
