**Background:**

Government Code Section 54970, known as the Maddy Act, requires the City Council to annually, by December 31<sup>st</sup> of each year, prepare a list of all regular and ongoing boards, commissions and committees, which are appointed by the City Council of the City of Yuba City, with the name of the incumbent appointee, the date of the appointment, the date the term expires and the necessary qualifications of the positions. The Maddy Act also requires this list to be posted at the public library and be available to members of the public.

None.


**Recommendation:**

Direct staff to post the Annual City of Yuba City Boards and Commissions Appointment List according to the Maddy Act Requirements.


