NOTES:

- A. The landscape plans will comply with the requirements of the water efficient landscape ordinance (MWELO). Elements of the Landscape Documentation Package:
 - (a) The Landscape Documentation Package shall include the following six (6) elements:
 - (1) project information;
 - (A) date
 - (B) project applicant
 - (C) project address (if available, parcel and/or lot number(s))
 - (D) total landscape area (square feet)
 - (E) project type (e.g. new, rehabilitated, public, private, cemetery, homeowner-installed)
 - (F) water supply type (e.g. potable, recycled, well) and identify the local retail water purveyor if the applicant is not served by a private well
 - (G) checklist of all documents in Landscape Documentation Package
 - (H) project contacts to include contact information for the project applicant and property owner
 - (I) applicant signature and date with statement, @I agree to comply with the requirements of the water efficient landscape ordinance and submit a complete Landscape Documentation Package
 - (2) Water Efficient Landscape Worksheet;
 - (A) hydrozone information table
 - (B) water budget calculations
 1. Maximum Applied Water Allowance (MAWA)
 2. Estimated Total Water Use (ETWU)
 - (3) soil management report;
 - (4) landscape design plan;
 - (5) irrigation design plan; and
 - (6) grading design plan.

NOTES:

- A. Place 2" -3" size cobble in swales as indicated as well as low lying areas or at drop inlets as required.
- B. Place 2" 3/4 size crushed rock over landscape fabric as indicated. Install 'Permaloc Clean Line' 3/8" x 4" aluminum edging with mill finish (MF), between decomposed granite and adjacent shrub beds or lawn areas.
- C. Place moss rock fieldstone boulders as indicated
- D. Around trash enclosures, carports, pool equipment, electric transformers, cable boxes, etc.) landscaping shall be designed to provide a visual screen.
- E. A Soils Fertility Test with recommendations shall be provided with the Landscape documentation Package per the Water Efficient Landscape Ordinance (MWELO) Requirements. The Landscape Contractor is responsible for obtaining a soils report. The soils test shall be collected after grading operations and prior to installation of landscape materials. The Landscape Contractor shall install all soil amendments, as recommended or better, to correct deficiencies noted by the soils report
- F. Shrub planting shall be a minimum five-gallon size. Groundcover plants used for mass planting shall be containerized woody, shrub groundcover plantings planted no farther apart than three (3') feet on center in order to achieve full coverage within one (1) year.
- G. Landscape planting include drought-tolerant, ornamental, native species, complement the architectural design of structures on the site, and are suitable for the soil and climatic conditions specific to the site.

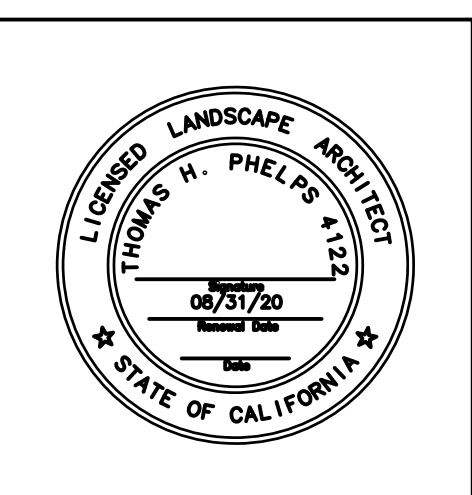
