Summary

Subject: Proposed Water and Wastewater Rates for Fiscal Year 2019/20

Recommendation: A. Conduct a Public Hearing and after consideration,

B. Adopt a Resolution setting the water rates at a rate less than the

Proposition 218 approved rates effective July 1, 2019

C. Adopt a Resolution setting the wastewater rates at a rate less than the

Proposition 218 approved rates effective July 1, 2019

Fiscal Impact: The scheduled rate increase will fund ongoing operation and maintenance

expenses, provide adequate debt-service coverage, and fund capital improvement projects identified as Priority 1 & 2 as part of the Water and

Wastewater Rate Study adopted in 2016.

Purpose:

To ensure adequate revenues in the Water and Wastewater Enterprise Funds for operations and maintenance, debt service coverage, and capital improvement projects.

Background:

Council adopted a Water and Wastewater Rate Study on April 5, 2016, which proposed adjustments to the City's water and wastewater rates over the next 5 years to fund ongoing expenses, provide adequate debt-service coverage, and fund priority capital projects.

In accordance with Proposition 218, a protest public hearing took place on June 8, 2016, and protests were received and tabulated. The City Clerk determined that there was not a majority protest of the proposed rate adjustments. The rates approved through the Proposition 218 process are shown in Attachment 3 for water and 4 for wastewater.

On June 21, 2016, City Council adopted Water and Wastewater Ordinances which have provisions requiring that the City Council review the rates on an annual basis as part of the fiscal year budget review process, prior to the July 1 implementation of the increases for each year. Council retains the authority to set by resolution the actual rates less than the maximum rates approved through the Proposition 218 process.

In July 2016, June 2017, and June 2018, City Council adopted resolutions setting the water and wastewater rates effective August 1, 2016, July 1, 2017, and July 1, 2018, respectively. For FY's 16/17, 17/18, and 18/19, the water rates were set at an amount below the approved Proposition 218

rates and the base allocation was increased for each meter size. The adopted water rates are reflected in Attachment 3.

For FY's 16/17 and 17/18, the Proposition 218 approved wastewater rates were implemented. However in FY 18/19, the wastewater rates were set at an amount below the approved Proposition 218 rates. The adopted wastewater rates are reflected in Attachment 4.

In June 2018, as part of the presentation related to the FY 18/19 water and wastewater rates, staff presented the anticipated rate increases for FY 19/20. Those increases were expected to be 7% for water and 8% for wastewater. During the January 22, 2019, Water and Wastewater Workshop, Council directed staff to evaluate three options for rate implementation for FY 19/20. The options are as follows:

Water Rates

- 1. No Increase
- 2. 3.5% Increase
- 3. 7.0% Increase

Wastewater Rates

- 1. No Increase
- 2. 4.0% Increase
- 3. 8.0% Increase

Analysis:

Staff has worked with the consultant that prepared the Water and Wastewater Rate Study, NBS, to update the water and wastewater rate models and develop the three requested options for water and wastewater rates for FY 19/20.

Water Rates:

In FY 18/19, water customers continued to achieve significant conservation as reflected in Attachment 5. The average of 20.3% conservation exceeds the 15% conservation assumed in the water rate model. Even though a 10% rate increase was implemented in FY 18/19, due to the higher conservation amount, it is anticipated that water sales revenues will only be approximately 6.5% higher than FY 17/18.

At the January 22nd workshop, Council requested that staff analyze the three options noted above, which are all below the approved Proposition 218 rates. Table 1 reflects the three rate options and the Proposition 218 approved rate.

Table 2 shows the additional revenue and net cash flow from the respective rate increases. The net cash flow is calculated by deducting the operating expenses and debt service from the revenues, and is cash available for Capital Improvement Projects (CIP).

At the June 4th Council meeting, as part of the FY 19/20 budget adoption hearing, Phil Treanor requested that the public be made aware of the "profit structure" of the Water and Wastewater Funds. Mr. Treanor had made a similar written inquiry prior to the Council meeting and the Finance Director provided the following response, "With revenues exceeding expenditures it gives the appearance that these utilities are profit generators. However, there are very large capital improvement project (CIP) needs so while revenues exceed expenditures there will be a time when expenditures exceed revenues when large CIP projects are funded. The Water and Wastewater master plans show significant CIP project requirements. The CIP budgets for Water and Wastewater are a good place to review where these funds will be expended."

Also at the June 4th Council meeting, the Finance Director requested that Council reallocate the 2013 Water Certificates from a split of 75% new customers/25% existing customers to 50% new customers/50% existing customers. This results in an additional allocation of \$347,886 to the debt service funded through water rates. This allocation is not reflected in Table 2 above as the rate models were completed prior to Council authorizing the reallocation. It will impact the funds available for projects.

Wastewater Rates:

In FY 18/19, even though an 8% increase was implemented, it is anticipated that revenues will only be approximately 6.1% higher than FY 17/18. At the January 22nd workshop, Council requested that staff analyze the three options noted above, which are all below the approved Proposition 218 rates. Tables 3 and 4 reflect the three rate options and the Proposition 218 approved rates.

Table 5 shows the additional revenue and net cash flow from the respective rate increases. Again, the net cash flow is calculated by deducting the operating expenses and debt service from the revenues, and is cash available for Capital Improvement Projects (CIP). The net cash flow shown does not take into account the anticipated increase in cost for biosolids disposal.

With the anticipated completion of the Wastewater Master Plan in early 2020, and the current Water and Wastewater Rate Study covering through June 30, 2021, it is expected that staff will be bringing a contract to Council for consideration in 2020 to update the Water and Wastewater Rate Study. An update takes several months and a Proposition 218 process can take several months if it is decided that rate increases are necessary.

Fiscal Impact:

The proposed FY 19/20 budget assumes no water and wastewater increases. However, staff recommends adopting a 7% increase for the water rates and an 8% increase for the wastewater rates. With the recent completion of the Water Master Plan, there are significant capital projects that need to be funded to address aging infrastructure, increases in operating expenses, and with the reallocation of the 2013 Water Certificates, the debt service costs have increased. Staff is currently working on the Wastewater Master Plan and there are significant capital projects that will need to be funded to address aging infrastructure, increases in operating expenses, and the debt service requirements will continue at their current level for years to come.

With all of that said, if Council chooses to adopt a smaller increase, at a minimum, staff recommends a 3.5% water rate increase and a 4% wastewater rate increase to keep up with inflation.

If Council chooses no rate increases this year, there are sufficient funds to cover operating expenses and debt service. However, there will be less funds available for capital projects. This will impact future rate studies as the backlog of capital projects continues to grow.

Alternatives:

- 1. Direct staff to consider a different option for implementation of water and/or wastewater rates. Staff can run the rate models with other scenarios and provide a financial analysis of additional rate options. This will impact the implementation date of July 1st and result in a change order to the City's contract with NBS.
- 2. Adopt the water and wastewater rates with an effective date of August 1, 2019. In past years, customers have complained about the July 1st implementation date. The billing process is such that meter readings are conducted on the first of each month and the billings sent out toward the end of the month for the prior month. With a July 1st implementation date, the rate increase is applied to June water consumption, with the bill sent out in late July. Council can direct staff to change the effective date to August 1, 2019, so that the rate increases apply to July consumption.

Recommendation:

- A. Adopt a Resolution setting the water rates at a rate less than the Proposition 218 approved rates effective July 1, 2019.
- B. Adopt a Resolution setting the wastewater rates at a rate less than the Proposition 218 approved rates effective July 1, 2019.
