- D. Authorize staff to make minor modifications or changes to address incorrect items and bring information back to the City Council

A. Adopt **Resolution No. 19-121** authorizing that the current Development Impact Fees, including Water and Wastewater Connection Fees, remain in effect until otherwise modified by the City Council

The motion was passed with a unanimous vote.

Councilmember Cardoza moved and Councilmember Espindola seconded the motion to:

B. Adopt Resolution No. 19-122 designating Councilmembers Shaw and Espindola to steer the Ad Hoc Development Impact Fee Committee to be formed for a period of not more than one year. Councilmember Boomgaarden was designated as the alternate.

The motion was passed with a unanimous vote.

24. Cellular Water Meter Replacement Project

Councilmember Boomgaarden moved and Councilmember Espindola seconded the motion to:

- A. Adopt **Resolution No. 19-123** approving the plans and specifications for the Cellular Water Meter Replacement Project and authorizing advertisement for bids on the project
- B. Adopt **Resolution No. 19-124** authorizing the use of specialized equipment from Badger Meter, Inc. with the finding that it is in the best interest of the City
- C. Authorize the City Manager to amend the Professional Services Agreement with Coastland Civil Engineering of Auburn, CA, subject to approval as to form by the

City Attorney, in the amount of \$97,000 for a total contract amount of \$122,000 to provide additional pre-construction data analysis/integration and engineering services during construction for the Cellular Water Meter Replacement Project, with the finding that it is in the best interest of the City

The motion was passed with a unanimous vote

25. Feather River Mill Hotel Incentive

Councilmember Cardoza moved and Mayor Harris seconded the motion to:

Discuss and consider the approval **of Resolution No. 19-125** of the City of Yuba City Transient Occupancy Taxes Reimbursement Agreement with Yuba City Hotel, L.P. to incentive operation of a Holiday Inn Express on the former Feather River Mill Project site. Approval of this Agreement supersedes and replaces the 2018 Agreement

The motion was passed with a unanimous vote.

26. Professional Services Agreement with FM3 Research for a Public Opinion Survey

Discuss and Consider Authorizing the City Manager to enter into a Professional Services Agreement with FM3 Research , in an amount not to exceed \$30,000, with approval by the City Attorney, to provide a Public Opinion Survey, with the finding that it is in the best interest of the City.
