Subject:	Postpone Yuba City Board & Commission Recruitments from June 2020 to September 2020
Recommendation:	Postpone recruitment for Personnel Board, Youth Commission and Regional Housing Authority Yuba City Citizen Representative with term endings as of June 30, 2020 and one unscheduled vacancy until September 2020
Fiscal Impact:	None.

#### Purpose:

To postpone recruitments for Boards and Commissions with term ending dates of June 30, 2020 to September 30, 2020 due to Stay-At-Home social distancing requirements.

#### Background:

It is the goal of the City Council to have a diversified group of citizens serving on their Boards and Commissions. Traditionally, the recruitment process begins in April, with interviews and appointment by Council in June.

The Personnel Board members are appointed from July 1<sup>st</sup> through June 30<sup>th</sup> and serve 4-year terms. The Youth Commission members are also appointed from July 1<sup>st</sup> through June 30<sup>th</sup> and serve 2-year terms.

On April 7<sup>th</sup>, the City received a resignation notice from the City's citizen representative on the Regional Housing Authority Board. This position was appointed in 2018 for a 4-year term, from January 1, 2018 through December 31, 2021.

Because of the COVID-19 social distancing order and the fact that schools are closed until the beginning of the next school year, staff is requesting postponement of recruitment until the new school year is in session.

#### Analysis:

The following Boards and Commissions have positions with term endings as of June 30, 2020, along with an unscheduled vacancy:

### Personnel Board

The Personnel Board meets on an as needed basis. The primary function of the Personnel Board is to hold hearings and make investigations and/or recommendations which may be considered desirable on any matter of personnel policy and report its findings to the Council or the City Manager as may be appropriate; and serve as a fact finding, mediation, or conciliation board when so requested in matters of employer-employee relations.

Two members of the 5 member board have the term limit of June 30, 2020. A quorum of Board members would still remain until September.

#### Youth Commission

The Youth Commission normally meets on a monthly basis. The purpose of the Youth Commission is to act in an advisory capacity to the City Council, City Manager and the Community Services Director in all matters pertaining to youth and all general matters concerning issues affecting youth and the City of Yuba City.

Three members of the 9 member board have terms ending as of June 30, 2020, however, traditionally several other members resign after only one year on the Commission because of graduation or changes in scheduling/circumstances.

The area high schools, as well as current Youth Commission members, are crucial in getting the word out regarding the Youth Commission. Recruitment of new diversified applicants will be more successful once school is in session.

#### Regional Housing Authority

Per the Agreement with the Regional Housing Authority of Sutter and Nevada Counties, each Governing Body shall appoint a citizen representative for a term of four years, per Section 34246.5 of the California Health & Safety Code. City staff coordinates with the Housing Authority for applicants for the position.

Notice will go out to all current Board and Commission members notifying them that their terms are up and the recruitment process is being moved to September. Advertisements for the open positions will be started in May through the Appeal-Democrat, the City's website and social media platforms.

#### Alternatives:

Do not postpone the recruitments and set-up virtual interviews.

# Recommendation:

Postpone recruitment for Personnel Board, Youth Commission and Regional Housing Authority Yuba City Citizen Representative with term endings as of June 30, 2020 and one unscheduled vacancy until September 2020.
