# Summary

Statewide Park Development and Community Revitalization Program Subject:

(Prop 68 Funding)

Recommendation: Adopt a Resolution authorizing the application for grant funds from the

> California Department of Parks and Recreation Statewide Park Development and Community Revitalization Program in the amount of approximately \$3,100,000 for the renovation and improvement of Sam

Brannan Park.

Fiscal Impact: No anticipated fiscal impact at this time.

#### Purpose:

To enhance City recreation facilities in underserved areas and encourage residents to utilize and benefit from outdoor activities at City parks.

#### Background:

The California Department of Parks and Recreation has been delegated the responsibility by the Legislature of the State of California for the administration of the Statewide Park Development and Community Revitalization Grant Program. Statewide Park Program (SPP) competitive grants will create new parks and new recreation opportunities in critically underserved communities across California. A total of \$254,942,000 is available for the current round of funding and 20% of the funds will be awarded to projects that expand or renovate existing parks. The maximum grant request per application is \$8,500,000, and the minimum grant request is \$200,000. There is no local match required. The application deadline is December 14, 2020 and funded projects must be complete three (3) months before March 30, 2025. The Office of Grants and Local Services will announce awardees in the summer of 2021.

Sam Brannan Park, located at 812 Gray Avenue, is located in an underserved area and has been identified as eligible for the SPP grant by the City's grant services consultant, Blais & Associates. Unlike many of the other City parks, Sam Brannan Park meets the grant's "critically underserved" requirement, which identifies thresholds for the Median Household Income and number of people living in poverty within 0.5 miles of the project site.

The City submitted a grant application for the same program in 2019 in the amount of \$3,026,534. In August 2020, the Community Services Director participated in a "strengths and weakness" debrief call with the State Parks Officer. The only weakness of the 2019 application was a higher number of acreages for the Critical Lack of Park Space criteria, a higher MHI, and a lower number of people living in poverty as compared to the other applications received. These criteria are beyond the City's control.

Sam Brannan Park is currently utilized by the City for a number of recreation programs and events, including the annual Food Truck Event, and was the site of the recent Sam Brannan Court Restoration and Conversion Project, which installed pickleball courts and tennis courts in 2019.

#### Analysis:

In order to complement recent and proposed improvements, the City desires to utilize SPP grant funds to fully renovate Sam Brannan Park and add needed recreation amenities and infrastructure. The proposed project includes a full inclusive playground, skate park lighting, pickleball/tennis court lighting, a complete walking path with solar perimeter lighting, a bathroom, a high-efficiency irrigation system, a shade structure, four (4) security cameras, 30 picnic tables, and new trees.

The Community Services Department has and will continue to seek input from park participants via surveys, our Commissions and will also look to local organizations for support and potential partnerships as part of the grant application and project planning process.

# **Fiscal Impact:**

The total cost for the proposed park is estimated to be \$3,100,000. The Statewide Park Development and Community Revitalization Program grant will pay 100%.

# **Alternatives:**

Do not authorize the application. If not approved, staff will need to seek funding from alternative sources for the proposed improvements to Sam Brannan Park.

#### **Recommendation:**

Adopt a Resolution authorizing application for grant funds from the California Department of Parks and Recreation Statewide Park Development and Community Revitalization Program in the amount of approximately \$3,100,000 for the renovation and improvement of Sam Brannan Park.

WHEREAS, the State Department of Parks and Recreation has been delegated the responsibility by the Legislature of the State of California for the administration of the Statewide Park Development and Community Revitalization Grant Program, setting up necessary procedures governing the application; and

WHEREAS, said procedures established by the State Department of Parks and Recreation require the Applicant to certify by resolution the approval of the application before submission of said application to the State; and

WHEREAS, successful Applicants will enter into a contract with the State of California to complete the Grant Scope project;

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Yuba City hereby approves the filing of an application for the Sam Brannan Park Renovation Project; and

- Certifies that said Applicant has or will have available, prior to commencement of any work on the project included in this application, the sufficient funds to complete the project if the grant is awarded; and
- 2. Certifies that if the project is awarded, the Applicant has or will have sufficient funds to operate and maintain the project, and
- 3. Certifies that the Applicant has reviewed, understands, and agrees to the General Provisions contained in the contract shown in the Grant Administration Guide; and
- 4. Delegates the authority to the Community Services Director to conduct all negotiations, sign and submit all documents, including, but not limited to applications, agreements, amendments, and payment requests, which may be necessary for the completion of the Grant Scope; and
- 5. Agrees to comply with all applicable federal, state and local laws, ordinances, rules, regulations and guidelines.
- 6. Will consider promoting inclusion per Public Resources Code §80001(b)(8 A-G).
