RESOLUTION OF THE CITY COUNCIL OF THE CITY OF YUBA CITY ACCEPTING THE SUTTER COUNTY REGISTRAR RECORDER/COUNTY CLERK'S OFFICIAL CANVASS AND OFFICIAL STATEMENT OF VOTES CAST FOR THE CONSOLIDATED MUINICIPAL ELECTION HELD ON TUESDAY, NOVEMBER 3, 2020, AND DECLARING THE RESULTS THEREOF

WHEREAS, a Statewide General Election and City Municipal Election were held and conducted in the City of Yuba City on Tuesday, November 3, 2020 as required by law; and

WHEREAS, in all respects the election was held and conducted as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, the Sutter County Registrar Recorder/County Clerk canvassed the returns of the election and certified the results to the City Council, and those results are received, attached, and made a part hereof as "Exhibit A".

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF YUBA CITY, DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. The vote totals for the Consolidated Municipal Election held on November 3, 2020 in the City of Yuba City, as certified by Sutter County are as follows: The whole number of ballots cast in all precincts including vote by mail were 43,264. The total number of ballots cast in the City of Yuba City Council contest were 42,880. The total number of ballots cast in the City Clerk of the City of Yuba City contest were 21,882. The total number of ballots cast in the City Treasurer of the City of Yuba City contest were 20.550.

SECTION 2. The City Council does declare and determine that:

(a) The names of persons voted for at the election for Member of the City Council are as follows:

Wade Kirchner (13,446 votes received) Shon Harris (12,998 votes received) Manny Cardoza (10,745 votes received) Gerry Mains (5,691 votes received)

(b) The names of persons voted for at the election for City Clerk are as follows:

Jackie Sillman (21,882 votes received)

(c) The names of the persons voted for at the election for City Treasurer are as follows:

Spencer Morrison (20,550 votes received)

SECTION 3. That the number of votes given at each precinct to each person and the number of votes given in the City to each person for the respective offices are listed on Exhibit "A", attached.

SECTION 4. The City Council does declare and determine that:

- (a) Wade Kirchner and Shon Harris were elected as Members of the City Council for the full term of four years.
- (b) Jackie Sillman was elected as City Clerk for the full term of four years.
- (c) Spencer Morrison was elected as City Treasurer for the full term of four years.

SECTION 5. The City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election, administer the Oath of Office, and shall have each person subscribe to it and file it in the office of the City Clerk. All of the persons so elected shall then be inducted into the office to which they have been elected.

The foregoing resolution was duly and regularly introduced, passed, and adopted by the City Council of the City of Yuba City at a Regular meeting thereof held on the 1st day of December 2020.
