Summary

Subject: City of Yuba City Advisory Board Appointment List
Recommendation: Note and File the 2020 Local Appointment List and Direct Staff to post on the City's website
Fiscal Impact: None.

Purpose:

To post an appointment list of the City's Advisory Boards in accordance with Government Code Section 54972 (the Maddy Act).

Background:

On or before December 31 of each year, each legislative body shall prepare an appointments list of all regular and ongoing boards, commissions, and committees which are appointed by the legislative body of the local agency. This list shall be known as the Local Appointments List. The list shall contain the following information:

- (a) A list of all appointive terms which will expire during the next calendar year, with the name of the incumbent appointee, the date of appointment, the date the term expires, and the necessary qualifications for the position.
- (b) A list of all boards, commissions, and committees whose members serve at the pleasure of the legislative body, and the necessary qualifications for each position.

The legislative body shall either post a copy of the list on its Internet Web site or designate the public library with the largest service population within its jurisdiction to receive a copy of the list.

Analysis:

The City of Yuba City operates under the City Council-Manager form of government with five elected City Council members. The Mayor and Vice-Mayor are elected by the City Council annually at the first meeting in December. Open positions on the City's advisory boards are advertised on the City's Website, in the Appeal-Democrat and through Social Media. The Advisory Board Screening committee, which is traditionally made up of the Mayor and Vice-Mayor, interview all candidates for positions on the Boards and Commissions and make recommendations for appointment to the whole City Council in an open and public City Council meeting. Positions on boards and commissions appearing on the Local Appointment List can be filled by qualified citizens from the community. Positions filled by members of the City Council are not required to appear on the Local Appointment List.
