#### **Summary**

**Subject:** 2021 ADA Improvements Project (Plans & Specifications)

**Recommendation:** Adopt a Resolution approving the plans and specifications for the 2021 ADA

Improvement Project, and authorizing advertisement for bids on the project.

Fiscal Impact: Engineer's Estimate \$310,000.00 – Account No. 1220

(ADA Public Facilities Sidewalk Improvements)

#### Purpose:

To promote full participation, self-sufficiency, equal opportunity, access, and safety by constructing Americans with Disabilities Act (ADA)-compliant improvements in accordance with the City's ADA Self Evaluation & Transition Plan for the Public Right-of-Way.

#### Background:

On July 17, 2012, the City adopted the *ADA Self-Evaluation & Transition Plan for the Public Right of Way* (Transition Plan). This Transition Plan identifies physical obstacles in Yuba City's public right-of-way facilities that limit accessibility of activities to individuals with disabilities. In addition, the Transition Plan describes methods to achieve ADA compliance and identifies priorities for implementation.

Using the priorities noted in the Transition Plan, as well as complaints logged through the City's yc311 system and directly with the Public Works Department, the 2021 ADA Improvements Project scope of work includes the upgrade of 33 pedestrian access ramps and 140 linear feet of sidewalk at locations shown on Attachment 2. This is also a part of the general repairs necessary to the upkeep of the City's sidewalk, curbs, and gutters and addresses Council's Goals #6 (Maintain and Enhance Our Quality of Life) and #7 (Identify and address our infrastructure financial needs).

#### **Analysis**:

Public Works has prepared the project plans, specifications, and cost estimate for the 2021 ADA Improvements Project. The focus of this project is to remove access barriers.

With Council approval of the plans and specifications and authorization to advertise for bids, staff proposes the following schedule:

The plans and specifications for the project are on file in the Public Works Department at City Hall and at http://www.yubacity.net/publicworksplans.

Construction management and inspection will be administered by the City's Public Works Department staff.

#### Fiscal Impact:

The estimated total project cost is \$310,000.00. This estimate includes contingency and construction management costs. CIP Account No. 1220 (ADA Public Facilities Sidewalk Improvements) has adequate funding programmed for this project.

A detailed fiscal impact and any necessary fiscal appropriations will be presented to Council at the time of award based on the actual bid amounts.

#### **Environmental**:

Through the preliminary engineering processes associated with federal funding, the City completed all necessary environmental documents required by the U.S. Department of Housing and Urban Development (HUD). Through the HUD environmental review process, City staff determined that the project is categorically excluded under 24 CFR 50.20(a)(1), special projects directed to the removal of material and architectural barriers that restrict the mobility of accessibility to elderly and persons with disabilities.

Staff has also performed a preliminary environmental assessment of this project relative to California Environmental Quality Act (CEQA) requirements and determined that it falls within the Class 1 Categorical Exemption set forth in CEQA Guidelines Section 15301, as concrete replacement and utility alignment adjustments within existing City facilities is defined as repairs, maintenance, or minor alterations of existing public facilities, involving negligible or no expansion. Further, none of the exceptions to Categorical Exemptions set forth in CEQA Guidelines 15300.2 apply to this project.

#### **Alternatives:**

- B. Delay or cancel proposed project.

#### **Recommendation:**

Adopt a Resolution approving the plans and specifications for the 2021 ADA Improvements Project, and authorizing advertisement for bids on the project.

WHEREAS, the Public Works Department intends to solicit bids for construction of the 2021 ADA Improvements Project.

Further, none of the exceptions to Categorical Exemptions set form in CEQA Guidelines Section 15300.2 apply to this project.
- 2. The plans and specifications for the 2021 ADA Improvements Project be approved.
- 3. The Public Works Department is hereby authorized and directed to advertise for bids for the 2021 ADA Improvements Project.
