Summary

Subject: Approve Regional Appointments to the Feather River Air Quality Management District (FRAQMD) Board of Directors for 2021

Purpose:

Approve changes of the member jurisdiction appointments to the Feather River Air Quality Management District Board of Directors.

Background:

The governing body of the Feather River Air Quality Management District is the nine member Board of Directors that includes five members from the two counties and four members from the four incorporated cities. Whenever a jurisdiction changes a member of the FRAQMD Board, the remaining jurisdictions must approve the new appointees.

The Board of Directors meet on the first Monday of every even month at 4:00 p.m. The next meeting is being held on February 1, 2021. The City of Yuba City representative is Councilmember Grace Espindola, as confirmed by the Council on January 19, 2021.

Analysis:

A request for approval of the recommended members to the Board of Directors has been received from FRAQMD for the City of Marysville and City of Wheatland representation. This recommendation has been deemed to be compliant with the 2004 Amended and Restated Agreement.
