## Summary

**Subject:** Capital Acquisition Request – Wheel Balancer

**Recommendation:** A. Approve a mid-year capital acquisition to purchase a wheel balancer for

the Fleet Division from Tech Supply, Inc. of Hayward, CA.

B. Authorize budget transfers in the amount of \$620.26 from Account No. 6605-62801 and \$7,803.68 from Account No. 6605-63401 to Account No.

6605-69201.

Fiscal Impact: \$8,423.94 – Account No. 6605-69201 (Capital Acquisition)

## Purpose:

To authorize a mid-year capital acquisition request to purchase a wheel balancer as it is not economically prudent to delay the purchase until FY 21/22.

## **Background:**

The Fleet Division (Fleet) of the Public Works Department maintains the majority of the City's fleet of vehicles and equipment. Fleet has a wheel balancer at the shop that is used on a routine basis. Specifically, it is used every Monday and Tuesday when patrol vehicles are serviced, and periodically when other vehicles need new tires.

To staff's knowledge, the wheel balancer was purchased in the late 1980's. It has been updated and repaired a few times. In late February, the main display control board burned up and cannot be repaired.

### Analysis:

With the failure of the current wheel balancer, staff is taking wheels for balancing to local tire shops. In addition to the cost of the tire shop to balance the wheels, there is the added cost of staff having to drop off the wheels and pick them up.

Staff has evaluated two different manufacturers of wheel balancers and is recommending the purchase of a wheel balancer manufactured by Hunter Engineering Company (Hunter) as they believe it is better suited to Fleet's operation. Staff obtained three quotes and is recommending award to Tech Supply Inc. of Hayward, CA, in the amount of \$8,423.94.

## **Fiscal Impact**:

There are sufficient funds in Fleet's budget to cover the purchase amount of \$8,423.94. Staff is requesting budget transfers in the amount of \$620.26 from Account No. 6605-62801 (Professional Development) and \$7,803.68 from Account No. 6605-63401 (Special Equipment O&M) to Account No. 6605-69201 (Capital Acquisition) so that there are sufficient funds in the appropriate account.

## **Alternatives:**

- 1. Deny the purchase.
- Direct staff to request the acquisitions in the Fiscal Year 21/22 budget.

## **Recommendation:**

- A. Approve a mid-year capital acquisition to purchase a wheel balancer for the Fleet Division from Tech Supply, Inc., of Hayward, CA.
- B. Authorize budget transfers in the amount of \$620.26 from Account No. 6605-62801 and \$7,803.68 from Account No. 6605-63401 to Account No. 6605-69201.




