Recommendation:	Consider a monetary Sponsorship request from Yuba Sutter Chamber of Commerce of \$6,250.00 to assist in funding the Film Yuba-Sutter Film Commission		
Fiscal Impact:	Monetary sponsorship in the amount of \$6,250.00		

### **Council's Strategic Goal:**

This Community Sponsorship will benefit the overarching strategic goal of quality of life and help with advancing fiscal responsibility.

#### Purpose:

Film Yuba-Sutter is an organization intended to attract and support the film industry in the Yuba-Sutter Community. A Film Commission such as Film Yuba-Sutter is a one-stop resource for film, TV, and commercial production. Film Yuba-Sutter is being established to attract production to the Yuba and Sutter communities.

#### **Background:**

Film Yuba-Sutter will provide tremendous opportunities for Yuba-Sutter. The tax revenue that can be generated through local production activities can be significant.

Location film production has a widespread economic impact that can benefit our entire community. Each location shoot means local jobs for camera operators, sound and lighting technicians, electricians, caterers, plumbers, carpenters, animal trainers, truck drivers, makeup artists, graphic artists, photographers, hairdressers, set designers, and production assistants. These location dollars are spent on hardware, props, film, photo development, plants, paint, lumber, cleaners, furniture, portable toilets, generators, clothing, entertainment, food, lodging, and gasoline.

The Chamber of Commerce has been working closely with a dedicated committee with representation and support from Yuba-Sutter Arts & Culture and Conejo Bros., Media along with several film industry experts, including Film Shasta, Film Commissioner, Sabrina Jurisich, who has been instrumental in providing guidance on the formation of Film Yuba-Sutter.

### Next steps and Timeline once all funding is secured:

• January 2022: Establish a formal Film Commission Committee to meet quarterly, which will include a representative from each investor entity as well as film industry experts and local business and non-profit organization representatives.

The purpose/mission of the Film Yuba-Sutter committee: To contribute to economic development in Yuba and Sutter counties by promoting and supporting film and video production and other film-related activities.

- January 2022: Secure a consultant to assist in launching Film Yuba-Sutter.
- January 2022 May 2022: Website design and build.
  - 1. This will include cataloging Yuba-Sutter amenities, locations, vendors, jobs, etc.
- January 2022: Create social media platforms, including but not limited to Facebook and Instagram.
- March 2022: Initiate process for county/ city designation: Establishing a model filmmaking process ordinance.
- By July 2022: Establish memberships and affiliations with the following groups:
  - 1. Film Liaisons in CA Statewide (FLICS)
  - 2. California Film Commission
- By December 2022: Attend up to 2 tradeshows to promote filming in Yuba-Sutter.
