**Subject:** Film Yuba Sutter Commission Committee  
**Recommendation:** Adopt a Resolution appointing Councilman Harris to the Film Yuba Sutter Commission Committee  
**Fiscal Impact:** None

**Purpose:**

To contribute to economic development in Yuba and Sutter counties by promoting and supporting film and video production and other film-related activities.

**Council's Strategic Goal:**

Support of the Film Yuba Sutter Committee benefits Council's overarching goal of quality of life and fiscal responsibility.

**Background:**

The Film Yuba Sutter Commission (Commission), formed earlier this year, is an organization intended to attract and support the film industry in the Yuba-Sutter community. In January, City Council approved a monetary sponsorship of the Commission in the amount of \$6,250, and it was noted at that time that the Commission would be forming a Film Yuba Sutter Committee (Committee) to meet quarterly. The Committee is to be comprised of a representative from each investor entity as well as film industry experts and local business and non-profit organization representatives.

**Analysis:**

As the City is an investor entity, the Commission is requesting that a Councilmember be appointed to the Committee. Mayor Shaw is recommending that Councilman Harris be appointed to the Committee. There is no term associated with this appointment, so Councilman Harris would remain on the Committee as long as Council does not change the appointment, or until the expiration of his term as a Councilmember.

**Alternatives:**

Appoint a different Councilmember to the Committee.

**Recommendation:**

Adopt a Resolution appointing Councilman Harris to the Film Yuba Sutter Commission Committee.
