



Yuba City Lighting and Landscape District Nos. 2-6 Background

- City annually levies and collects special assessments to maintain and service landscaping and lighting improvements
- Assessments approved by property owners
- District Nos. 2-6 have provisions for a Cost of Living Adjustment (COLA)
- COLA is based on Consumer Price Index (CPI) from January to January
 - COLA increased 7.48% from last year

Yuba City Lighting and Landscape District Nos. 2-6 Background (cont.)



- July 5, 2022: Council ordered Engineer to file reports for Districts
- July 19, 2022: Council adopted Resolutions approving reports, and Resolutions setting a Public Hearing for August 16, 2022

Yuba City Lighting and Landscape District Nos. 2-6 Analysis

- Engineer's Reports are on file in City Clerk's Office
- Reports describe each District, improvements, methods of assessment, and proposed assessment for each parcel
- Districts 3, 4, 6 District 5 Zones of Benefit B-L will see increases in annual levies
- District 2 (Zone of Benefit A) and District 5(Zone of Benefit A) will see decreases in levies




 Modify assessment amounts or cancel Districts and fund lighting, landscaping and various other items with alternative sources


Yuba City Lighting and Landscape District Nos. 2-6 Recommendation




- Conduct a Public Hearing
