3. Expedited permitting procedures for Electric Vehicle Charging Stations pursuant to Assembly Bill 1236

Councilmember Cleveland moved and Councilmember Buckland seconded the motion to:

Adopt **Resolution No. 18-013** authorizing the City Manager to Amend Executive Service Employee Employment Agreement and approve a supplemental appropriation of \$40,700 to the FY 2017/2018 adopted budget

Councilmember Cleveland moved and Councilmember Cardoza seconded the motion to:

- A. Adopt **Resolution No. 18-014** initiating annexation proceedings for the area known as South Yuba City, calling for a municipal election
- B. Approve an agreement with Sutter County to consolidate services for the election to be held on Tuesday, June 5, 2018
- C. Authorize the Finance Director to make a supplemental appropriation of \$40,000 to Account No.1710-62701(City Clerk Elections) from unallocated Fund Balance
