Adopt **Resolution 21-065** describing improvements and ordering the Engineer of Work to file a report with regard to Yuba City Landscape Maintenance District No. 1, to continue the Maintenance District, pursuant to the Landscaping and Lighting Act of 1972

The motion was passed with 4 votes.

11. Yuba City Lighting and Landscape Maintenance District Nos. 2, 3, 4 & 5 (Town Center and 69 Subdivisions throughout Yuba City), and Yuba City Lighting and Landscape Maintenance District No. 6 (Commercial District) Report Filing

Councilmember Espindola moved and Councilmember Kirchner seconded the motion to:

Adopt **Resolution 21-066** describing improvements and ordering the Engineer of Work to file reports with regard to Yuba City Lighting and Landscape Maintenance District Nos. 2, 3, 4, 5, and 6, to continue the Maintenance Districts, pursuant to the Landscaping and Lighting Act of 1972

The motion was passed with 3 votes.

15. Shopping Carts Ordinance Update

Councilmember Harris moved and Vice-Mayor Shaw seconded the motion to:

Adopt **Ordinance 003-21** of the City Council of The City of Yuba City Amending Chapter 22 to Title 5 of The Yuba City Municipal Code Regulating Shopping Carts, and waive the second reading

The motion was passed with a 4-1 vote. (Mayor Boomgaarden opposed)

16. Renewal of agreement between the City of Yuba City (City) and the Yuba City Unified School District for the services of School Resource Officers

Councilmember Espindola recused herself

Councilmember Kirchner moved and Vice-Mayor Shaw seconded the motion to:

- A. Adopt **Resolution 21-069** of the City of Yuba City approving a School Resource Officer agreement with the Yuba City Unified School District (Attachment 1)
- B. Authorize the Chief Financial Officer to make budget adjustments as necessary

The motion was passed with 4 votes.

- A. Adopt **Resolution 21-073** approving a two-year Memorandum of Understanding with the First Level Manager group
- B. Adopt a Resolution authority the Finance Director to amending the salary schedule
- C. Authorize the Finance Director to transfer funds from Contingency account 4215-65601 in the amount of \$57,000
- D. Approve a supplemental appropriation to Salary and Benefits, Fund 507 in the amount of \$41,000
- E. Approve a supplemental appropriation to Salary and Benefits, Fund 518 in the amount of \$59,100
- F. Approve a supplemental appropriation to Salary and Benefits, Fund 619 in the amount of \$12,600

- B. Authorize the Finance Director to transfer funds from Contingency account 4215-65601 in the amount of \$34,300
- C. Approve a supplemental appropriation to Salary and Benefits, Fund 507 in the amount of \$7,100
- D. Approve a supplemental appropriation to Salary and Benefits, Fund 518 in the amount of \$15,400

The motion was passed with a unanimous vote

22. Fire Local 3793 Side Letter

Councilmember Harris moved and Councilmember Espindola seconded the motion to:

- A. Adopt **Resolution 21-075** approving a Side Letter with Fire Local 3793 extending the Memorandum of Understanding until December 31, 2023
- B. Authorize the Finance Director to transfer funds from Contingency account 4215-65601 in the amount of \$143,100

The motion was passed with a unanimous vote

- C. Authorize the Finance Director to transfer funds from Contingency account 4215-65601 in the amount of \$32,715
- D. Approve a supplemental appropriation to Salary and Benefits, Fund 507 in the amount of \$2,531
- E. Approve a supplemental appropriation to Salary and Benefits, Fund 518 in the amount of \$2,531

The motion was passed with a unanimous vote

24. Implement the E-Team amendments, unrepresented Confidential group and Mid-Managers, First Level Managers and Local 3793 Memorandum of Understanding (MOU) changes to the salary schedule

Vice-Mayor Shaw moved and Councilmember Kirchner seconded the motion to:

- A. Adopt **Resolution 21-078** to adjust the City's salary schedule to incorporate the E-Team amendments, unrepresented Confidentials, Mid-Managers, First Level Managers and Local 3793 MOU changes
- B. Authorize the Finance Director to transfer funds from Contingency account 4215-65601 in the amount of \$16,200

The motion was passed with a unanimous vote

25. Hooper Ranch Estates Phase 2 (Annexation #4 of property into CFD 2017-1)

Councilmember Espindola moved and Councilmember Kirchner seconded the motion to:

- A. Adopt **Resolution 21-079** stating the intention to annex certain territory into City of Yuba City Community Facilities District 2017-1 (Municipal Services), setting a time and date for the Public Hearing thereon, and adopting a boundary map showing the territory proposed to be annexed

The motion was passed with a unanimous vote

- B. Hold a Public Hearing for the annexation of Tentative Map No. 20-03 into CFD 2017-1

Mayor Boomgaarden opened the Public Hearing. Hearing no Public Comment, Mayor Boomgaarden closed the Public Hearing

Councilmember Kirchner moved and Councilmember Harris seconded the motion to:

- C. Adopt **Resolution 21-080** authorizing Annexation No. 4 of territory into City of Yuba City Community Facilities District 2017-1 (Municipal Services), authorizing the levy of a special tax, and submitting the levy of tax to the qualified electors

The motion was passed with a unanimous vote

- D. Hold an election for the annexation of Tentative Map No. 20-03 into CFD 2017-1

The sealed Ballot was opened by the Deputy City Clerk. Four (4) votes were received from Tanner Judkins, Chief Financial Officer of Riverland Homes, Inc. approving the Ballot Measure. Special Election Ballot, Annexation No. 4 was unanimously approved.

Councilmember Espindola moved and Vice-Mayor Shaw seconded the motion to:

- E. Adopt **Resolution 21-081** making certain findings, declaring and certifying the results of an election and adding property as City of Yuba City Community Facilities District 2017-1 (Municipal Services), Annexation No. 4

The motion was passed with a unanimous vote

26. Hooper Ranch Estates Subdivision (Subdivision Agreement and Final Map Approval)

Vice-Mayor Shaw moved and Councilmember Harris seconded the motion to:

Adopt **Resolution 21-082** approving the execution of a Subdivision Improvement Agreement with Riverland Homes, Inc. providing for public improvements associated with the Hooper Ranch Estates Subdivision Map, approving the Hooper Ranch Estates Final Map, accepting dedication of rights-of-way and easements shown thereon and authorizing the filing of the map. [Subdivision is located north of Monroe Road, west of Hooper Road, and south of Jefferson Avenue]

The motion was passed with a unanimous vote

27. Proposed Water and Wastewater Rates for Fiscal Years 21/22, 22/23, and 23/24

- A. Adopt **Resolution 21-083** setting the water rates for Fiscal Years 21/22, 22/23, and 23/24
- B. Adopt **Resolution 21-084** setting the wastewater rates for Fiscal Years 21/22, 22/23, and 23/24

The motion was passed with a 4-1 vote. (Vice-Mayor Shaw opposed)
