**13. Right-of-Way Access and Use Agreement for Deployment of a Citywide Fiber Optic Network with SiFi Networks Yuba City LLC**

Adopt **Resolution 21-128** authorizing the City Manager to enter into a Right-of-Way Access and Use Agreement for deployment of a citywide fiber optic network with SiFi Networks Yuba City LLC

**14. Development of Plans and Specifications for Second Groundwater Well Installation**

Councilmember Espindola moved and Vice-Mayor Shaw seconded the motion to:

- A. Adopt **Resolution 21-129** awarding a Professional Services Agreement to West Yost & Associates, Inc of Davis, CA in the amount of \$572,498 for development of plans and specifications for the groundwater well, hydrogeologic services, and other services in preparation for and during the construction of a new potable groundwater well, with the finding that it is in the best interest of the City
- B. Adopt a Resolution authorizing the City Manager to execute the contract on behalf of the City, subject to review and approval as to legal form by the City Attorney

Introduce an Ordinance of the City Council of the City of Yuba City Adding Chapter 13 (Disclosure Statement Filings and Retention) to Title 2 of the Yuba City Municipal Code To Allow For Paperless Electronic Filing, and Availability of Statements for Public Review and Record Retention

The motion was passed with a unanimous vote

Adopt **Resolution 21-130** of the City Council of the City of Yuba City Declaring its Intention to Transition from At-Large to Division-Based Elections

The motion was passed with a unanimous vote

**17. Police Officers' Association Memorandum of Understanding (MOU)**

Vice-Mayor Shaw moved and Councilmember Harris seconded the motion to:

- A. Adopt **Resolution 21-131** approving a two-year Memorandum of Understanding with the Police Officers' Association
- B. Authorize a supplemental appropriation from unallocated general funds for FY 2021/2022 in the amount of \$502,100

The motion was passed with a unanimous vote

**18. Police Sworn Mid-Managers Memorandum of Understanding (MOU)**

Vice-Mayor Shaw moved and Councilmember Espindola seconded the motion to:

- A. Adopt **Resolution 21-132** approving a two-year Memorandum of Understanding with the Police Sworn Mid-Managers
- B. Authorize a supplemental appropriation from unallocated general funds in the amount of \$49,400 for FY 2021/2022
