Adopt **Resolution 21-141** of the City Council of the City of Yuba City awarding a construction contract to SAK Construction, LLC., in the amount of \$1,185,744.00, and approving a Professional Services Agreement with Inferrera Construction Management Group, Inc., for construction management and inspection services, and authorizing the City Manager to execute the contracts on behalf of the City, subject to review and approval
