## WATERSENSE® LABELED SHOWERHEADS \$20 REBATE

The City of Yuba City is offering rebates of up to \$20.00 to Yuba City water customers for the purchase of a WaterSense® Labeled Showerhead.

Did you know that standard showerheads use 2.5 gallons of water per minute (gpm)? Showerheads that earn the WaterSense® label must demonstrate that they use no more than 2.0 gpm. The average family could save 2,900 gallons of water per year by installing WaterSense® labeled showerheads.

- Applies to WaterSense<sup>®</sup> Labeled Showerhead purchases made after July 15, 2014
- Two (2) WaterSense<sup>®</sup> Labeled Showerhead rebates per location
- Rebate postmark must be within 90 days of purchase

Rebates will be issued as a check payable to the person indicated on the application. Rebates do not include labor cost for installation. Maximum rebate amount per showerhead is up to \$20.00 or the total cost (excluding sales tax), whichever is less. Rebates may take up to six weeks to process.

## WATERSENSE® LABELED TOILETS \$100 REBATE

The City of Yuba City is offering a rebate of up to \$100.00 when you upgrade your old toilet using 3.5 gallons per flush (gpf) or higher, to a new high performance WaterSense® model.

Toilets are by far the main source of water use in the home, nearly 30 percent of an average home's indoor water consumption.

By replacing old, inefficient toilets with WaterSense® labeled models, the average family can reduce water used for toilets by 20 to 60 percent—that's nearly 13,000 gallons of water savings for your home every year! They could also save more than \$110.00 per year in water costs, and \$2,200.00 over the lifetime of the toilets.

## WATERSENSE® LABELED SMART IRRIGATION CONTROLS \$75 REBATE

The City of Yuba City is offering a rebate of up to 50% or \$75.00 (whichever is less) toward the purchase of a WaterSense® Labeled Smart Irrigation Control.

Residential outdoor water use in the United States accounts for nearly 9 billion gallons of water each day, mainly for landscape irrigation. Experts estimate that as much as 50 percent of this water is wasted due to overwatering caused by inefficiencies in irrigation methods and systems. WaterSense® Labeled controllers allow watering schedules to better match plant and landscape water needs without overwatering.



Maximum rebate amount per timer is up to 50% off of the total cost (excluding tax) or \$75.00, whichever is less. Rebates may take up to six weeks to process.
